Privacy Policy

Your privacy is very important to Legg Mason Asset Management Hong Kong Limited ("LMAMHK") and its affiliates (collectively hereafter "Franklin Templeton"). To the extent any information you provide to Franklin Templeton constitutes personal data, we have set procedures for the use of that information.

From time to time, it is necessary for you to supply Franklin Templeton with personal data in connection with the use of this website, in the course of business relationship with Franklin Templeton, for provision of services to you, and/or for processing requests from you. The kinds of data that may be collected include, without limitation, name, job title, email address, phone number, address, and name of the company you represent.

Failure to supply such personal data may result in your inability to use or access this website, or parts of this website, and/or Franklin Templeton being unable to process your request and/or provide services to you. Please note that if you telephone Franklin Templeton, calls may be monitored or recorded to maintain and improve services.

Personal data held by Franklin Templeton relating to you will be kept confidential but Franklin Templeton may transfer such information to the following parties whether within or outside Hong Kong for the purposes set out above:

1. the ultimate holding company, subsidiaries and/or affiliates of LMAMHK, and the employees, officers and directors of LMAMHK and such holding company, subsidiaries and/or affiliates;
2. the intermediaries of Franklin Templeton (including third party financial institutions such as banks and insurers);
3. any agent, contractor, cloud provider or third party service provider who provides administrative, research, design, launch, data storage, telecommunications, software development and

4. application, printing, letter-shopping, mailing, computer, payment, securities clearing and settlement or other services to Franklin Templeton in connection with the operation of its business; and
4. any legal, regulatory, judicial, administrative, public or law enforcement body, or governmental, tax, revenue, monetary, securities or future exchange, court, central bank or other authorities, or self-regulatory or industry bodies or associations of financial service providers, or any of their agents with jurisdiction over all or any part of Franklin Templeton.

Our website utilizes a variety of technologies (including, without limitation, cookies and web beacons) to collect, store, and aggregate data about usage and browsing patterns. These technologies may identify users and can store information about them and their usage and browsing patterns.
